Minutes detailed:

Agenda #1: To rescind previous voting for proxy vote. Motion carried.
There will be no proxy voting

Agenda #2: To accept the wording of Captain Cooper (approved by National Safety Officer) for the Black Powder issue.
Exact wording: "RULE #7

Loaded/partially loaded guns (blanks, powder, or primers only) are not to be worn/carried/used outside of the stage/performance area.

Blanks and dummy loads with live primers are not to be carried/worn casually by any performer either in their pockets or in the loops of a cartridge belt.

All loaded blanks, preloaded cylinders, and all other performance ammunition will be carried in an ammo box, preferably metal, for the entire team by a designated team SO or armory. These containers should always be available for event SO inspection. The containers should only be opened during test fire/splatter tests, in the designated loading/unloading area with permission of the SO or during that teams performance window.

Note: Performance window is 10 minutes before show time and/or until released from performance/loading area by SO."

Agenda #3: To reduce the time of competition to a minimum of 5 minutes from the 8 in the bylaws.

It was discussed in the officer's forum at length, but the consensus of the officers in the chat room was to drop this item and take no action on it.
